

ON 9-16-06 AT 2300 I, OFFICER LOUIS HINDS IV (M471), WAS DISPATCHED TO A CALL IN SARASOTA OFF OF S.R. 72 AT THE MARTINS GATE ENTRANCE TO THE MTAKKA STATE PARK. I ARRIVED AT THE PARK AT 2330 TO FIND THE SHERIFF'S DEPARTMENTS SPECIAL AGRICULTURAL UNIT ALREADY ON SCENE. THE DEPUTIES HAD SEVERAL VEHICLES STOPPED ON THE INSIDE ON MARTINS GATE. AFTER TALKING WITH THE DEPUTIES I WAS ABLE TO GET A PICTURE OF WHAT WAS GOING ON.

EARLIER THAT AFTERNOON AT LEAST TWO SUBJECTS, A MR. ROBERT C. SHAREK AND MARK E. BIEHL ENTERED THE MYAKKA PARK WITH THEIR VEHICLES. THE TWO MEN DROVE AROUND THE MARTINS GATE, FINDING A HOLE IN THE FENCE LINE THAT THEY COULD FIT THEIR VEHICLES THROUGH. THE MEN ALSO DROVE PAST SEVERAL "NO TRESPASSING" SIGNS THAT CLEARLY STATE "FOOT TRAFFIC ONLY IN THIS SECTION OF THE PARK." FURTHER MORE, THEY DROVE PAST A LARGE SIGN THAT STATES THAT THE SECTION OF LAND THAT THEY WERE ABOUT TO DRIVE ON WAS PROTECTED WILDERNESS PERSERVE.

AFTER OFF-ROADING (MUDDING) INSIDE THE PARK ALL AFTERNOON THE MEN GOT BOTH THEIR VEHICLES STUCK IN PARK. IT WAS AT THIS TIME THAT THE MEN CALLED SOME FRIENDS TO COME PULL THEM OUT. THE FRIENDS ENTERED THE PARK BY DISMANTALING THE FENCE SO THAT THEY COULD SLIP THE PAD LOCK OVER THE FENCE POST. ONCE THE FRIENDS HAD GAINED ACCESS TO THE PARK THEY ALSO GOT STUCK. THEN EVEN MORE PEOPLE WERE CALLED TO COME WITH THEIR VEHICLES TO HELP. BY THE TIME IT WAS ALL SAID AND DONE THERE WERE 2-JEEPS,2-FORDS,1-HUMMER AND 1-TRACTOR IN AN AREA CLOSED TO VEHICLES.

AFTER TALKING WITH PARK SUPERVISORS AND D.E.P. WE DECIDED TO CHARGE THE DRIVERS OF ALL SIX VEHICLES WITH THE SAME THING. THE DRIVERS: ROBERT SHAREK, MICHAEL BELLFLOWER, MARK BIEHL, DAN WILCOX, RODNEY EDWARDS AND CHRISTOPHER KOVACH WERE CITED FOR: ILLEGAL ENTRANCE INTO A STATE PARK 62D-2.014(2)A, DESTRUCTION OF STATE LANDS 375.314 AND RESTRICTION TO DESIGNATED ROADWAYS IN A STATE PARK 62D-2.014(5). PICTURES WERE TAKEN OF THE SIGNS AND THE DESTRUCTION TO STATE LANDS.
