**SYNOPSIS:**

On fr 14mar08 met with Patricia Stuchler at 401 west venice ave reference verbal threats made by Michael Vellucci.

**INVESTIGATION:**

Stuchler said while she was investigating a code enforcement violation at 127 tampa ave, speaking with Michael Vellucci, Vellucci made verbal threats towards the code enforcement board. According to Stuchler, Vellucci said he would get even with anyone that found him guilty of any violation, financial or whatever.

Stuchler asked Vellucci not to make threats and according to Stuchler, Vellucci said he was not making threats. Stuchler said she took the statement and the way Vellucci said he was not making threats, as if Vellucci was making promises of future violence to city Code Enforcement personnel.

On su 16mar08 spoke with Michael Vellucci via cell phone, Vellucci said he had a conversation with Stuchler and may have been a little agitated. Vellucci said he never made any threats but did say he wanted to be heard by the board reference ordinance issues.

Vellucci said he suggested to Stuchler to have VPD officers present if it would make her feel more comfortable. Vellucci said he wanted to bring up several violations of city code in the same area of 127 tampa ave.

Vellucci said he is a "hot head" but is trying to discuss the issues in a calm, civilized manner. Vellucci said he would have a written statement and enumerate the issues he would like the code enforcement board to address at the meeting.

Stuchler wanted this incident documented because of prior incidents involving Vellucci. Stuchler said Vellucci will be attending a code enforcement meeting on 03apr08 at 0900 hours and would like VPD to have one or two officers present.

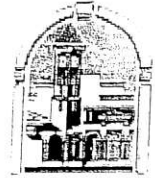
